MINUTE entry before the Honorable John Z. Lee: Status hearing held on 7/15/20. The Receiver should formulate a plan to collect all of the EquityBuild internal documents within the next 14 days and should discuss with the institutional lenders how to make the documents available for copying and/or processing. In the next thirty days, the parties should work together to draft a standard list of interrogatories and document requests for each claimant to be used as part of the claims process. In the next thirty days, the institutional lenders should formulate a plan to collect and process the EquityBuild internal documents, including whether the documents can be made available to other claimants and parties and on what terms. Telephone status hearing set for 8/13/20 at 2:00 p.m. In light of the COVID-19 pandemic and the related General Orders, the Court finds that it is necessary to conduct the status hearing via telephone conference.
