ORDER REGARDING SUMMARY PROCEEDINGS FOR GROUP 4

The Court, having reviewed the Framing Report for Group 4 (Dkt. 1543) submitted by Kevin B. Duff, as the receiver (“Receiver”) for Estate of Defendants EquityBuild, Inc., EquityBuild Finance, LLC, their affiliates, and the affiliate entities of Defendants Jerome Cohen and Shaun Cohen, IT IS HEREBY ORDERED THAT:

1. Group 4 of the Claims Resolution Process shall include claimants who submitted Proofs of Claim with respect to one or more of the following eleven properties (in Chicago, Illinois, except as indicated below):
