**RECEIVER’S RESPONSE TO DEFENDANT’S MOTION
TO CONTINUE JULY 10, 2019 EVIDENTIARY HEARING**

Kevin B. Duff, as the receiver (“Receiver”) for the Estate of Defendants EquityBuild, Inc., EquityBuild Finance, LLC, their affiliates, and the affiliate entities of Defendants Jerome Cohen and Shaun Cohen (collectively, the “Receivership Defendants”), objects to Defendant’s Motion to Continue July 10, 2019 Evidentiary Hearing (Docket No. 432). That same motion was denied by Judge Lee on July 1, 2019. (Docket No. 431)

In any event, the arguments Jerome Cohen raises in his newly filed motion are largely identical to those he advanced in support of the motion to continue he filed on June 27, 2019 and June 28, 2019 (Docket Nos. 425, 429).
